**CERTIFICATION OF NO OBJECTION TO APPLICATION [RE DOCKET NO. 748]**

The undersigned counsel to the Official Committee of Unsecured Creditors (the “Committee”), in the above captioned cases, hereby certify the following:

1. On December 2, 2008, the Court entered the *Administrative Order Under Bankruptcy Code Sections 105(a) and 331 Establishing Procedures for Interim Compensation and Reimbursement of Professionals* (the “Interim Compensation Order”) [Docket No. 263].

2. In accordance with the Interim Compensation Order, on March 3, 2009, Akin Gump Strauss Hauer & Feld LLP (“Akin Gump”) filed its *Third Monthly Application for Interim Allowance of Compensation and for the Reimbursement of Expenses for Services Rendered as Co-Counsel for the Committee for the Period From January 1, 2009 to and Including January 31, 2009* [Docket No. 748] (the “Application”) with the United States Bankruptcy Court for the District of Delaware.

3. As of March 25, 2009, the undersigned counsel has not received any answer, objection or other responsive pleading to the Application. Personnel at Greenberg Traurig, LLP have reviewed the Court’s docket in this case and no answer, objection or other responsive pleading to the Application appears thereon. Pursuant to the Notice of Application, objections were to be filed and served no later than March 23, 2009 at 4:00 p.m. Akin Gump did not grant any extensions of such objection deadline and has no knowledge of any other party granting any such extensions.

4. Accordingly, pursuant to the Interim Compensation Order and the Application, the Debtors are authorized to pay Akin Gump 80% of the fees requested in the Application (in the amount of \$533,705.25) and 100% of the expenses requested in the Application (in the amount of \$8,039.20).
